In another mandate, she successfully represented Groupama Asigurari in a series of antitrust litigations against the competition authority obtaining the reduction of a nearly EUR 8 million fine for an alleged concerted practice through information exchange to below EUR 500,000, upon dismissal of the last extraordinary appeal. Legal 500 2025 recommends Andrada as a *Leading Associate* in the Dispute Resolution and Intellectual Property areas.
